Calvin Smith, 80, of Foster, Kentucky, passed away on Saturday, September 20, 2008, at the St. Elizabeth Medical Center South in Edgewood. Born on June 12, 1928 in Breathitt County, Kentucky, he was the son of the late Elige and Mary Ann Turner Smith. He married Virginia Smith on December 25, 1952, and his dear wife preceded him in death on June 18, 2002. He retired as a coal miner with Arch Coal, Inc, and he faithfully served his country in the U.S. Army in Korea.
