Vivian Carol Snodgrass, 96, of Cold Spring, KY, formerly of Falmouth, passed away on Friday, January 23, 2026, at the St. Elizabeth Hospice Care Center in Edgewood.

Born on December 18, 1929, at her Grandmother Thompson's house in Pendleton County, she was a daughter of the late Howard and Anna Mary Thompson Snodgrass.
